### 15. Information on the 2020 Olympic Games in Tokyo (JPN)

#### General overview

The Rio Olympic Games just finished when we started to work on the preparation of the Tokyo 2020 Olympic Games. Based on the request of the International Olympic Committee, the involvement of the International Federations for the future Games increased and we can say that we are already working for the Paris 2024 Olympic Games.

For 2020, we already had visits and meetings. Each aspect of the organization of the Olympics was handled and some key points are already finalized.

#### The main topics are:

- The venue where wrestling will be held
- The plans of the venue and the equipment provided
- The final schedule for our sport and the competition format
- The accommodations for all our people (athletes, officials, Board Members)
- The training facilities
- The Test Event
- The qualification system
- The transports

#### **Competition Venue**

The Wrestling event will be organized in the exhibition hall "Makuhari Messe". We will have the advantage to keep the training facilities close to the competition venue. It will be in the same building. The wrestlers would have a training space in the same hall. It will help the organization of the delegations and their coaches.

The competition venue is 30km away from the Athletes' Village. There will be 40 km between the venue and the two Tokyo International Airports.

#### Date and Competition format

The dates for the competition have been fixed and approved by the IOC Executive Commission last July. Our competition will be held in the second week and will take 7 days (one day less than the previous editions). The competition will be organized from the 2<sup>nd</sup> until the 8<sup>th</sup> of August 2020. 3 weight categories per day will be organized on 3 mats. The competition format of 2 days per weight category will still be used for Tokyo.

At the moment, discussions are made about the schedule per session and which weight categories will be organized which day.

As a reminder, the Qualification System was already approved at the beginning of this year and can be found in the United World Wrestling website.

#### **Qualification Tournaments**

As you can see in the qualification system, we will have Continental Qualification Tournaments and one World Qualifier.



We take this opportunity to encourage your Federation to bid for one of these events as they will be our main competitions in 2019.

#### **Test Event**

This competition will be organized from the 20<sup>th</sup> to the 22<sup>nd</sup> of September 2019. An international tournament will be certainly organized, and the Organizing Committee will take care of inviting the National Wrestling Federations.

#### Accommodations

The allocation process for the accommodations (officials, Board Members) is always in progress. A visit will be organized at the end of the year, but the idea is to find accommodations close to the Competition Venue in order to avoid long drive and reduce to cost of the transportation.

#### **Wrestling House**

Based on the success of the project in Rio2016, a wrestling house will be open during the Olympic Games in order to allow the Wrestling Family, journalists and members from the IOC to have nice place where they can share good moments all together.

# 17. Updates to the UWW Financial Regulations

During it meeting on 5 August 2018 in Rome the UWW Bureau approved some amendments to the Financial Regulations regarding the organization fee of the following competitions. This decision aimed at harmonizing the fees between continents, considering their specificities.

In addition, the Olympic Games Qualifying tournaments are considered as major events and should be organized on higher standards. The UWW Bureau approved that the organization fees for these qualifying tournaments should reflect these high standards requirements.

#### 3. Guyana - Americas

All documents set forth in article 6.1 of the UWW Constitution were forwarded to the UWW Secretariat by the applicant, except a support letter from the Guyana Olympic Committee. The documents received comply with the requirements for the affiliation to United World Wrestling.

**Recommendation:** The Congress should approve the application of Guyana as an affiliated member.
