Mediterranean Committee of Associated Wrestling Styles

CMLA - Activity Plan - 2021

1. Representation

The Mediterranean Committee is an independent auxiliary organ of United World Wrestling and follows the regulations which are applied to the continental councils.

The committee brings together all the Mediterranean federations affiliated to the international federation. The Mediterranean Committee of Associated Wrestling Styles "CMLA" was created and established with the approval and under the guidance of the international federation and in compliance with its statutes and rules.

In January 2016, in agreement with the Boards of directors at the request of the UWW, the CMLA has established Regional Committee.

The office is the headquarters of the Federation of which is originated the President of CMLA. CMLA as an attached organization allowed the transfer of financial funds that was previously attached to those of the UWW.

In November 2016, was held in Madrid, the ordinary and Extraordinary Meeting to amend the statutes.

In August 2017, during the World Championship was held in Paris the elective General Assembly which renewed the office and its board of directors.

2. Aims and Principles

The committee brings together all the Mediterranean federations affiliated to the international federation. The Mediterranean Committee of Associated Wrestling Styles "CMLA" was created and is established with the approval and under the guidance of the international federation and in compliance with its statutes and rules.

The CMLA has legal personality under national law of the place of incorporation.

5. Activity Plan

This plan summons the main activities and development lines established by CMLA - Mediterranean Committee of Associated Wrestling Styles.

5.1. Board of Director's Meetings

The Board gets together one ordinary meeting every year, preferably during the month of January and, if needed, a second just before the Mediterranean Championships and also if needed, one extraordinary meeting preferably during the Senior World Championships.

In 2020 the executive board meeting of January took place in Nice, France.

the meeting of the executive board is held on April 24, 2021 by teleconference

5.2. General Assembly

The General Assembly meets annually during the Mediterranean Championships or Games.

In 2019, the General Assembly was held in Tunis during the Mediterranean Championships. 9 nations were represented.

In 2020, the General Assembly should have taken place in Loutraki (GRE) during the Mediterranean Championships. Like the Mediterranean championship, they were postponed in October 200 then June 2021 and finally canceled following the COVID pandemic and difficulties organization.

The General Assembly will take place in Xanthi (GRE) during the Mediterranean Championships between October 28 and 31, 2021.

5.3. Mediterranean Championship and women's Mediterranean team cup

In 2019 **the Mediterranean Championships** have been organized in Tunis (TUN) by the Wrestling Federation of Tunisia, for Seniors U23 and Cadets in all the three Olympic styles, on the month of May (03-05). We highlight the participation of 83 U23 athletes and 70 cadet athletes over two days of competition.

10 nations participated: Algeria, Egypt, Spain, France, Greece, Portugal, Serbia, Slovenia, Syria, Tunisia.

The Women's Mediterranean Team Cup was organized in Tunis on May 5th, 2019 with the participation of 5 teams (Algiers, France, Greece, Spain and Tunisia). The rules put in place allowed all the teams to meet and for this event to be a success, with an excellent welcome from Tunisian personalities and institutions.

For 2020 the organization of the Mediterranean Championship in Greece has been postponed due to the COVID pandemic.

For reasons of organization and availability, the city of Xanthi has been selected.

In accordance with the wishes of the CMLA, in agreement with the Hellenic federation and President Theodoros Hamakos (Acting President of UWW - Europe, UWW Bureau member), the Mediterranean Championship and the Balkan Championship will be combined for the widest possible participation.

On the other hand, a youth internship or camp will be organized during the event.

In accordance with UWW and the recommendations of President Theodoros Hamakos regarding the COVID pandemic, we will take all precautions in respect health constraints.

In connection with UWW and the Hellenic federation we will put in place medical protocols and necessary measures to preserve our young athletes

In 2021, for its 9th edition, the Mediterranean Championship will be held in Greece in Xanthi from October 28 to 31.

A significant effort is made to have very reasonable fees, namely:

- Competition - Board and lodging - € 80,00 per day;
- Competition - Entry fee - € 30,00 (Juniors only);
- Training camp - Board and lodging - € XXX per day.

As usual in previous years, the Mediterranean Committee will support the organization of the championship by transferring the entry fee to the organizing federation. If needed and justified, an assistance fund may be mobilized to support the organizing federation in welcoming the participating federations.

5.4. Training Camp

CMLA organized a training camp for wrestlers in July 2018 in Komotini (GRE) with the collaboration of the Greek Federation and a French organization (WATW). This camp aims to improve and promote the development of the sportive, cultural and social exchanges between the wrestlers from the Mediterranean basin. 20 young girls from France, Greece, Azerbaijani, Bulgaria were able to enjoy this sports camp with endurance test, training and culture.

In 2021, October.

Regarding the training camp for young athletes, we can organize it before or after the competitions. This camp will be held in the town of Komotini (50 km from the town of Xanthi) at the sports facilities of the University of Thrace Demokritius and participants can take ergogeometric examinations there if they wish. In addition, in collaboration with Demokritius University, we could also organize a conference or round table for the exchange of expertise.

5.5. Women & Sport Plan

Following the reelection and inclusion of Ms. Teresa Mendez Mayo as active Board Member of CMLA and under her guidance and the support of the rest of the Boards of Directors, some promotion activities for Women and Wrestling were presented during the 2018 General Assembly, namely a women's tournament by teams, the day after the Mediterranean Championships to improve the feminine participation in wrestling.

After the success of the organization of the first Women's Team Mediterranean Cup in Tunis in 2019, a second edition will be held in Xanthi (GRE) in October 2021

5.6. Commissions

A call to all federations to propose their candidates to the several CMLA Commissions was issued at the beginning of this year following the Board of Directors meeting. The CMLA Board will appoint the members according to their abilities for the Commission concerned. The National Federations must be well aware of the fact that they have to bear the travel expenses of their members for at least one meeting per year and that all members must speak either French or English.

For 2021, this effort will focus on the medical commission and on the technical and refereeing commission.

5.7. Internal and External Relations

Over the year 2021 the Board of Directors will continue to promote and develop its internal as well as its external relations: meeting and establishing communication with the National Federations and Continental Councils (via either meeting in place and/or at competitions).

Communication and publication of documents is ensured by the CMLA Facebook page and on the CMLA page on the UWW website. A newsletter is published each year, one at the start of the year and one after the Mediterranean Championship.
