2019 ACTIVITIES SUMMARY

- In the framework of the WADA Code Compliance Monitoring Program, the ITA assisted the UWW in the implementation of certain corrective actions issued by WADA in the scope of the Corrective Action Report (CAR) issued after a WADA audit. In particular, the ITA provided responses, documentation, policies and/or general guidance in the following areas of the compliance programme: ADAMS; Budget & Report; Testing & Investigations; Results Management.
- ✓ 979 Urine and 458 hGH samples were collected In Competition and Out of Competition during the 2019 UWW Testing Programme.
- Of the 269 OOC test attempts coordinated by the ITA on behalf of UWW, 13% were unsuccessful. The average across other sports is 10%.





- ✓ The ITA coordinated IC testing at 26 UWW events during 2019 collecting 744 Urine and 41 hGH samples.
- UWW's Testing Programme generated 1,838 Steroidal notifications consisting of 422 atypical notifications.
- This resulted in 13 IC/OOC APMU test recommendations, 44 IRMS analysis requests and 9 samples were stored as part of UWW's Long Term Storage Strategy.

RISK ASSESSMENT

In collaboration with the UWW, ITA elaborated a Risk Assessment aligned with WADA's ISTI. This service includes:

- the collection of a large spectrum of data that influence the risk of doping in Wrestling
- the integration of this material in a structured methodology that assess the Physiological / Country / Individual Risks
- the analysis and combination of all the relevant parameters to provide the prerequisites for an effective and proportionate Test Distribution Plan

TEST DISTRIBUTION PLAN

ITA in consultation with UWW, developed a tailormade TDP that prioritizes appropriately between: disciplines (physiological risk), athletes (country, performance & testing history risks), periods during the season, types of testing, types of samples collected and types of analysis according to the TDSSA. This TDP was also updated regularly as and when additional and relevant information was provided such as APMU recommendations and intelligence.










RTP/TP: COUNTRY HEATMAP












