Opening the conference, Mr. Hamakos, greeted the audience, welcoming the delegates as well as the Acting President and Bureau Members from UWW and UWW-EC. He then gives the floor to Mr. Manfred Werner, who as President of the Wrestling Federation of Germany presents greetings and highlights the importance of hosting this event to wrestling in Germany and all the efforts of the organizing committee in creating an atmosphere to ensure all the participants have the best possible conditions. Mr. Werner welcomes everyone to Dortmund and marks this moment as the moment he passes the torch in Germany to younger generations.

Mr. Lalovic presents Mr. Werner with a UWW trophy in recognition of all the work he has done over the yers for the development of wrestling in Germany, Europe and the World.

Mr. Hamakos thanks the warm welcoming of the German federation and then gives the floor to the President of United World Wrestling, Mr. Nenad Lalovic, United World Wrestling President and International Olympic Committee Executive Board Member, welcoming all participants and highlighting the adversities and challenges that the wrestling family worldwide overcome and will continue to face in the future.

Concerning the election of the writer of the minutes of the present conference, the UWW Bureau Member and President of the Federation of Portugal, Mr. Pedro Silva was unanimously approved. For the Electoral Commission, Mr. Pedro Silva was unanimously elected as President and Mr. Iglesias, President of the Federation of Spain and Mr. Stuer, Secretary General of the Federation of Belgium as members.

The minutes of the conference in Rome were unanimously approved.

Regarding the point 5 of the agenda, Mr. Dittmann made a detailed oral presentation of the report that was previously and in due time made available to everyone. The report was unanimously approved.

Mr. Hamakos gives the floor to Mr. Pircalabu, to address the financial report.

Mr. Pircalabu highlights the main revenues and expenses mentioned in the financial report and finishes his address proposing that the report be approved.

Mr. Hamakos opens the floor for debate and questioning.

Following this, the report is unanimously approved.

Mr. Bryusov made an oral presentation of the report of the work of UWW's Centre in Sofia. The report was unanimously approved.

At this moment, Mr. Hamakos gives the floor to Mrs. Niamkey, UWW's Development Department Director, who makes a presentation regarding the programs and activities of the Department in Europe.

On the point 8 of the agenda, approval of the current tasks for the realisation of UWW- Europe's Program for the period 2021-2024, Mr. Hamakos makes a presentation and underlies that according to the decision of UWW's Bureau, a member of the Athletes Commission from Europe will have a seat at UWW-Europe's Bureau, with the right to speak but not to vote. Mr. Hamakos then opened the floor for debate. The plan was unanimously adopted.

The Acting President, Mr. Hamakos, then gave the floor to Mr. Pircalabu to address the UWW-Europe's budget for 2021, highlighting the main points mentioned in the documents and finishes his address proposing that the budget be approved.

The budget is unanimously approved.

On the 10th point on the agenda, calendar of UWW/UWW-Europe for 2022-2024, Mr. Hamakos presented all the hosts and the following made a presentation:

- ➤ 2022 Junior World Championship Sofia (Bulgaria);
- ➤ 2022 Senior European Championship Budapest (Hungary);
- ➤ 2022 U15 European Championship Zagreb (Croatia);
- ➤ 2022 U23 World Championship Pontevedra (Spain).

Before giving the floor to Mr. Silva to proceed with the elections, Mr. Hamakos informs the assembly that due to his recent appointment and unanimous election for the post of UWW Vice President and considering the responsibilities that that post comprises, he withdraws his candidature to the Executive Bureau of UWW-Europe.

Regarding the election of the members of the Executive Commission and of the President of UWW-Europe, Mr. Pedro Silva, President of the Electoral Commission, reports that after the verification of power of attorneys, the quorum is established at 36 countries and that the absolute majority is therefore established at 19 votes.

Mr. Silva then explains to the delegates all the rules and procedures concerning the elections. He then presents the candidacies for the post of member of the Executive Bureau of UWW-Europe and proceeds with the vote.

On the first round of the election of the members of the Executive Bureau of UWW-Europe, the results were the following:
