I. Pursuant to the UWW Constitution and regulations, I undersigned declare that:

- 1. As a UWW Bureau member, I have read, I understand and agree to be bound by and comply with all UWW regulations, rules and directives.
- II. Pursuant to the UWW Code of Ethics, I undersigned declare that:
- 1. I have read and understand the rules concerning prohibition against fraudulent and corrupt conducts as set forth in the UWW Code of Ethics. I understand that as a member of the UWW Executive Committee and/or Bureau I am subject to these rules.
- 2. I have read and understand the rules concerning conflict of interest set forth in the UWW Code of Ethics. I understand that as a member of the UWW Executive Committee and/or Bureau I am subject to these rules.
- 3. I understand that in the exercise of my functions on behalf of UWW and/or its Executive Committee and/or Bureau, I must be free of undue influence or other factors which may give rise to a conflict between my own interest or the interest of any other person and that of UWW.

I further understand that I am under a continuing duty to disclose all facts or circumstances that exist or arise and which create or could create such a conflict or the appearance of such a conflict in the eyes of UWW stakeholders or the public, in order that appropriate preventive measures may be taken.

To the best of my knowledge, there exist no facts or circumstances, past or present, which create or could create such a conflict or the appearance of such a conflict in the eyes of UWW stakeholders or the public.
